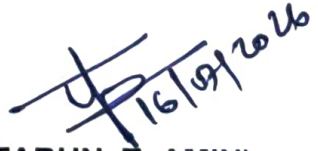

1. A Candidate who have been issued Nomination form for the different Posts as said above, and file their nomination with the Cash Fee of Rs. 2000/- but his nomination for the one post only of office Bearer of C&T Society has Been accepted at the time of Declaration of Final List of Candidates.
2. Loan defaulter is not eligible for filling for any post.
3. Members of society (Shareholders) as on 20.07.2026 will be entitled to cast their vote.
4. The Nomination fees once paid at the time of submission of Nomination will not be refunded in any case.
5. Casting of **01 (One)** Vote each for the post of **Secretary** and **Joint Secretary** is Compulsory.
6. Casting of **01 (One)** Vote each for the post of **Executive Committee Member (SC/ST)** is Compulsory as per bye-Laws.
7. Casting of **02 (Two)** Vote each for the post of **Executive Committee Member (Female)** is Compulsory as per bye-Laws.
8. For the post **Executive Committee Member** to ensure **tick mark** on nomination form for General/ Female/ SC or ST while filling up nomination otherwise it may get cancelled.
9. The Vote casted **more than or less than** one vote for the post of **Secretary, Joint Secretary & Executive Committee Member (SC/ST)** will be considered as rejected/ invalid Vote.
10. The Vote Casted **less than three Votes** for the Post of **Executive Committee Member (General)** also considered as rejected/ invalid Vote.
11. The Vote Casted **less than two Votes** for the Post of **Executive Committee Member (Female)** also considered as rejected/ invalid Vote.
12. The impression of seal in a Ballot paper of casted vote outside vote column will also be considered as rejected/ invalid Vote.
13. Elected body's tenure will be of five years i.e. 2026-2031.
14. Original ONGC Identity Card is Compulsory to be carried at the time of Casting of votes. However, any other Original Photo Identity Card like Aadhaar Card, Driving License, Passport, Pan Card, and Epic Etc. is also valid at the time of cast of votes. If, any Duplicate photo identity card is found during the verification process the same will be debarred from casting of votes at the time of polling.
